is a non-profit organization founded in 1967. We provide services in Charlotte, Collier, DeSoto, Glades, Hendry, Lee, Manatee, and Sarasota counties.

The mission of Epilepsy Services is to further the welfare of individuals with epilepsy and their families by providing direct services as well as important education and prevention programs.

Neurological evaluations, diagnostic testing, and blood level monitoring are provided. Case management, individual and group counseling, as well as employment and vocational assistance are provided.

We are affiliated with, and receive support from, the United Way in each of the eight counties we serve. Monetary donations are gratefully accepted.

Programs, Services and Eligibility Requirements

ELIGIBILITY: Services are available to Florida residents who have or are suspected of having epilepsy. Medical services are provided on a sliding fee scale basis to individuals who do not have health insurance.

MEDICAL SERVICES: Includes initial neurological evaluation, diagnostic testing (including EEG, MRI, CT Scan), blood work, and follow-along care through our Seizure Disorder Clinics.

MEDICATIONS: Assistance in obtaining medications through various resources, including the Department of Health Antiepileptic Drug Program.

CASE MANAGEMENT: Provides an array of services including psycho-social and educational assessment, crisis intervention, and information and referral.

VOCATIONAL SERVICES: Provides job-seeking and job-keeping skills training, basic computer skills training, and job placement assistance.

PREVENTION AND EDUCATION PROGRAM: Presentations and in-service trainings are offered to school personnel and students, medical professionals, caregivers, first responders, civic organizations, businesses and other members of the community.
